## **Tax Collection**

**All taxes collected up to and including September 30, 2011 will be at par. Taxes collected on October 1, 2011 through October 31, 2011 will be assessed a 2% penalty. Taxes collected in November will be assessed a 3% penalty.**

**NOVEMBER 1, 2011 IS THE LAST DAY TAXES MAY BE COLLECTED BY THE SCHOOL TAX COLLECTOR. THEREAFTER, FROM NOVEMBER 15, 2011 UP UNTIL 5:00 P.M. NOVEMBER 30, 2011, TAXES MAY BE PAID BY CERTIFIED FUNDS ONLY TO THE COUNTY TREASURER, P.O.BOX 5012, MONTICELLO, NY 12701. FROM DECEMBER 1, 2011 UNTIL JANUARY 1, 2012 SCHOOL TAXES MAY NOT BE PAID. The County Treasurer will add an additional 7% penalty and the school tax will be incorporated with State, Town and County tax to be levied in January 2012.**
